#### 3. President's Annual Report

Thanks everyone for attending this year's AGM.

This is another difficult school year for most of the parents. But we went through this together, with our school community, our teachers, the staffs and the Principal. It's glad to see that the students have resumed their school days sort of as usual.

This year, we have kept the P&C as a member of Australian Charities and Not-for profits Commission (ACNC) and the Federation of P&C Associations NSW. Thanks to our committee members, to make the registration renewal done and pay the insurance in time so all of our volunteers are covered properly all the time.

Many thanks to our Treasury and the Uniform Shop teams as we are having much better backend systems to ensure the smooth running of the Uniform Shop.

Like using VEND - the Inventory Management System and Xero (the accounting software we used for the Bookkeeper).

And a new online shop system to replace the Flexischools platform is on the way... most likely we can start it up next year.

Our Fundraising team have also done some fantastic jobs this year. The team managed to have some events like Harmony Day Tea towel, Mother's Day Stall, but unfortunately due to the Covid-19 restrictions again, we had no chance to run the rest which we have planned earlier such as Walkathon, Discos, Book Nook. Hopefully we can still run them next year.

In this year, we have allocated the funds to the school:

The donation (totally \$144,650) to the school for the refurbish buildings and playground, which includes the \$44,000 grant we applied and received from the Community Buildings Program, have also been allocated to the school for the refurbish of the school library. Two years ago, I submitted a suggestion to the Local Transport Committee and asked them to install some protection fence along the corner of Edgeworth David Avenue and Myra Street in Waitara. After chasing and with the help of our Principal and the local MP Mr Alister Henskens, I believe everyone should have noticed that from the beginning of this term, a concrete crash barrier has been installed over there which provides great protection to all pedestrians. I'm very glad to see that it eventually got done.
