Fundraising Committee Report – None.

Principal's Report - DC

- **Tell Them From Me (TTFM) Survey** Teachers and parent Survey will be out next week. We would love all parents to participate as it gives us some good data and feedback.
- NAPLAN Naplan will be mailed out on Thursday to our parents of the students in Year 3 and 5.
- Selective High School Due to COVID 19 restrictions in 2021, primary schools will not be required to provide school assessment scores for the 2022 Selective high school placement process for Year 7 entry in 2023. The removal of school assessment scores will result in a time savings for Principals. This approach was successfully used for 2021 placements in opportunity classes which were similarly affected by COVID 19. Primary school principals will continue the usual process of confirming information entered by parents in their applications and by adding relevant information on student background, disability and reasonable adjustments. More detailed communications will be provided in Term 4, 2021.
- **Opportunity Class Placement Test** The placement test scheduled for 6 October 2021 has been delayed. New testing arrangements for students will be announced as soon as possible.
- **Refunds** Refunds for all cancelled events and excursions are currently taking place. Forms for a refund are available on our <u>school website</u>.
- **Kindergarten 2022** Our Kindergarten page has been updated for our 2022 enrolments. We are unsure what the transition looks like at this point and will await further instruction from the DoE and NSW Health next term.
- We will let you know our return to school plans when we return in Term 4.
- I would like to sincerely thank our community for following the NSW Health regulations by keeping your children home and safe so our community/teachers can also feel safe. Please keep vigilant and numbers are rising in our LGA.

6. General Business

• **Music / Dance Performance** - AQ asked whether there would be any music or dance performances that the students are allowed to participate in the coming months. Mrs Barrat mentioned that the

school is not sure at this point in time during this lockdown. However, the school will communicate more details once they have received further info.
